Training & Support Contract

There are Two Ways to Purchase the RWB Process.

1.) Purchase the Complete Process With Personal Coaching. - \$999

2.) Purchase the Complete Process Without Personal Coaching. - \$599

The complete process consists of 14 emails with 18 attachments. This is a simple step-by-step process so each email will be sent one at a time and used in that same manner when teaching the process to your downlines. The difference with the personal coaching is that I personally walk you through the process in the same manner you will do with your prospects and new builders. Most people learn much better this way and I recommend it. However, if you feel you do not need this coaching, you can still buy the process at the reduced price listed above. When you read and study all of the training emails, you will clearly understand how to use it.

Personal Training Includes:

- 1.) Trainer will supply all support material for doing the RWB process by way of email. Trainee will keep a copy of each email and all attachments to be forwarded to all of their interested prospects as they continue the RWB process with their downlines only. All attachments are locked and cannot be changed. However, each email message can and should be changed with the new owners personal contact information.
- 2.) Trainer will do all the steps of the RWB process with the trainee as a real upline would do for a new builder including up to (6) 3-way phone presentations with trainee and his or her prospects.
- 3.) Trainer will do any extra personal phone appointments trainee may feel is needed for more support in learning the process, either directly with them or on a 3-way with their builders during the first 30 days of the contract.
- 4.) Trainer will supply lifetime email support for any updates that may be needed in the future.
- 5.) Trainee and their builders will be invited to all conference calls on the RWB process at no additional cost.
- 6.) Trainee will own all copyrights to re-produce all RWB training materials, without changes, to be used in building their business with their downlines only at no additional cost.
- 7.) Trainee will be added to all future business emails unless trainee request to be opted out.
- 8.) Trainer does not guarantee any future success using the RWB process and the trainee is fully aware of this. Once the training begins there will be no refunds.
- 9.) Trainee may request a new package to be sent to them if ever needed in the future due to a computer loss.
